We are waiting to get a quote for having a pool attendant.

Cedar has mailed letters to neighbors of 210 Maple Ridge for purchasing the lot with no response. We should maybe look into possible uses for the lot.

Amanda Smith will check with the lawn crew about the walk ways and ballfield.

The walking path is in need of new split rails and there might be a resident who has some to give away.

There was discussion and a complaint taken at the meeting by a resident.

Ernesto Mier will be looking for a new cleaning person and we should update the contract.

George Krause brought up an issue with taxes being filed late. Amanda Smith found that the accountant was in fact supposed to have filed and did not on time. She will be finding out more information on this.
